4. DECLARATIONS OF INTEREST: There were none.

5. APPLICATIONS:

WD/2008/0386/F Land to west of Five Chimneys Farm, Hadlow Down: Erection of a 12,000
bird, free range egg laying unit. *We strongly support this application. It is good use of agricultural
land and may provide employment locally. We commend the proposed planting of the coppices and
hedgerow.*

WD/2008/0401/F St Mark's C of E Primary School, School Lane: Provision of new classroom,
staff room and ICT room, plus new external play deck. *We fully support these plans to enable the
works to go ahead as soon as possible. The school is a very strong integral part of the community
which we wish to see continuing in the manner it has in the past.*

conversion (WD/2002/2900/F) to incorporate improved open plan floorspace to main barn and
provision of lower ground floor to rebuild east wing.

building.
