

MINUTES OF THE MEETING of Hadlow Down Parish Council held in Hadlow Down Village Hall, Hadlow Down

at 7pm on Tuesday 1st July 2025

Present: Councillors: Michael Lunn (ML) Chair (+WDC), Peter Weston (PW) Vice-Chair, Damon Wellman (DW), Alan Hobbs (AH), Ben Floyd (BF), David Munday (DM) and Stephen Lester (SL).

In attendance: Vicki Rutt (Clerk) and 6 members of public.

79. PUBLIC QUESTIONS – A resident raised a question about a planning application for Five Badgers, this is on the Agenda tonight. The school have reported to a resident that they can't access Smile Meadow due to a tree problem, AH to look at this. Action 1. Signage has gone up on the A272, stating road closed between 17-19 July but doesn't say why, Clerk to enquire. Action 2. A resident expressed his anger at the state of the roads in Hadlow Down, it is ridiculous and unfair. Why is Hadlow Down not being sorted, there is no logic behind what roads they do repair. ML suggested that this is deferred until ClIr Standley is present and perhaps a representative from the contractors could attend to answer questions? Action 3. ClIr Hobbs joined the meeting at 19:10.

A resident stated that his statement he read out at the 10th June PC meeting still stands, and he would like his comments to be remembered when discussing items in the confidential session. A resident stated that it is strange that the most used area of the playing field, the play area, is being affected and possibly moved to a much smaller area. ML stated that the PC are aware of the issues and concerns. A resident stated that when the plans were first published in 2015, there was not one objection to the moving of the play area.

- 80. APOLOGIES Apologies were received from Cllr Bob Standley (ESCC).

84. PLANNING APPLICATIONS

84.1 PLANNING APPLICATIONS

WD/2025/1411/FA for FIVE BADGERS, STONEHURST LANE, HADLOW DOWN, TN20 6LL

Variation of conditions 1, 2 and 3 of WD/2013/2348/FA (variation of condition nos. 1 and 2 of WD/2009/1456/FA. Change of use of land for stationing of two caravans for residential occupation by gypsy-traveller family) to allow for the use of the site for the stationing of 4 caravans as well as, to allow E J Moore to add his son, his partner and E J Moore's wife as named occupants of the site.

Standing Orders dropped. Query on what they are asking for, caravan or mobile home are the same. One fixed static home, one as a traveller home. Standing Orders reinstated.

PC commented – 7 Councillors objected to this application, so the decision was unanimous. Reasons are due to the over development and over intensification of the site that sits within a sensitive High Weald national landscape. That area is still underdeveloped and of a medieval unspoilt landscape supporting the High Weald Management Plan. Additional accommodation will create adverse traffic impact on a small lane. It will delay the restoration of the original site. They are doubling the size of the site and will continue to do so. Concerns were raised about how the sewage is dealt with and water abstraction.

84.2 ENFORCEMENT UPDATE

<u>Drakes Den</u> - is still at appeal pending decision.

<u>Wander Down</u> – going out to tender for direct action quotes.

<u>Tinkers Park</u> - there is currently a planning application WD/2025/0654/FR with our Planning Technical Team awaiting validation.

85. REPORTS FROM CLLR.BOB STANDLEY, ESCC & CLLR MICHAEL LUNN, WDC

ESCC - Cllr Standley had sent his apologies, his full written report is on the Parish Council website.

<u>WDC</u> - Cllr Lunn reported that it has been an interesting few days, with the recent changes there has been unintended consequences that the Alliance are starting to realise. The Overview and performance committee have changed significantly, therefore cabinet members are no longer needed to attend the committee. Discussion took place regarding the restructuring of the Minor and Major planning Committees. It was noted that if there is a minor planning application whereby the Parish has objected and it's recommended by WDC officer it will still be referred to

the local councillor but which could agree with officers or call in to committee but clear policy reasons have to be given. There was a discussion about the Owlsbury site in Uckfield which proposing up to 1700 homes and whether this could be approved by only 3 members. Cllr Lunn stated this was a possibility but unlikely to happen as Cllr Lunn said would be surprised if officers allowed such a major application to determined by just 3 members. BF explained he was surprised it was legal, Cllr Lunn informed Cllrs that legal aspects of the new constitution have been checked and was approved by the Wealden Alliance made up of Lib Dems, Greens and Labour Members

 - <u>b. New School Lane Sub-Station</u> It has been reported that UK Power Networks are planning to replace the old existing sub-station in School Lane in the relatively near future. Work has been done to ensure continued supply whilst this work takes place via rerouting the power. Exact timescales not yet known.

PW reported that his recent communication with a resident requesting another SID pole, are Cllrs content with his response. All agreed it was sensible to wait. Clerk to enquire. Action 6.
